Revision of Modular Exemption Fee

In view of the challenging task to review and evaluate the applications for modular exemption; the CCB has reviewed and deliberated on exemption process and its cost implication; we are pleased to inform that the National Council has supported the CCB's efforts; and the modular exemption fee is revised effective **1 January 2021** as follows:

1	Modular Exemption Application Processing Fee (non-refundable)	150	RM150
2	Modular Exemption Fee per module	RM100	RM300

EXEMPTION APPLICATION GUIDELINES

1. Application:

- Exemption application can be done online via 1st MFPC Portal (https://1st.mfpc.org.my/)
- Exemption application is applicable to those who hold Academic/Professional Qualifications listed in the MFPC Exemption List.
- Exemption enquiries can be forwarded to education@mfpc.org.my

2. Documents Required:

- Please ensure to upload listed documents in 1st MFPC portal:
 - Certificate of Degree/Diploma/Certificate
 - Transcripts/Results
 - Programme outlines and syllabuses (For courses not listed in MFPC Exemption List)

3. Fees Applicable:

- Application Fees
 - Kindly remit Modular Exemption Application Fee RM150 per application (non - refundable) to MFPC Secretariat together with every application.
 - ➤ Please be advised that you are required to remit to the MFPC Modular Exemption Fee RM300 per module once it has been approved. Payment must be made within 5 working days upon notification from the MFPC Secretariat. Otherwise, application will be deeming invalid; and applicant is required to resubmit fresh application.
