- Where finance meets gaming, art and AI



# **CEFI vs DEFI**

### **Centralised Finance (CEFI)**

- Regulated (Coinbase) & unregulated (Binance)
- Central Limit Order Book
- High liquidity
- Withdrawal limits
- Offchain virtual accounts
- Less variety

### **Decentralised Finance (DEFI)**


- Unregulated, Anonymous
- Onchain
- 3 types of DEX:
  - AMM (E.g. Uniswap)
  - Order Book (Gridex)
  - Aggregator (1Inch)
- Low liquidity (Slippage)
- More variety



CEX	S DEX
CEX	DEX
Centralized governance	Not controlled by centralized entities; rely on smart contracts to connect users and liquidity providers
Higher liquidity as early mover CEXes have the lion share of global crypto trading	Lower liquidity as DEXes are relative newcomers to the crypto trading space
Heavy regulatory scrutiny	Still largely unregulated sector that is far more lenient when it comes to AML&KYC
Traders are required to disclose personal information due to AML&KYC compliance	Traders can remain anonymous as no personal details are requested
Custodial - assets are controlled by the centralized exchange	Non-custodial - users maintain full control over their assets
Exposed to hacking vulnerabilities	Considered more secure due to their reliance on smart contracts
Higher transaction fees	Lower transaction fees
Easy to use interfaces and more beginner friendly	More complex to understand and not as user-friendly
A variety of trading options	More limited, but allowing for novel options such as liquidity mining
Coinbase, Binance, Kraken	Uniswap, Sushiswap, Curve Finance

## Non Fungible Tokens

Is a digital asset that represents ownership of a unique item or piece of content such as art, music, videos, tweets, or real world items.

#### **Assets:**

- Profile Pictures (PFPs)
- Land in the *metaverse* (digital real estate)
- Collectibles: <u>Art</u>, music, Tweets, Trump Cards
- Real world Items: e.g. Concert tickets






# What are the **Risks**?






